Dear GBCs, partners and sustainable building advocates,

Welcome to the April Global Update!

On the 20th March 2023, the [Intergovernmental Panel on Climate Change \(IPCC\) issued a stark and 'final reminder'](#) that the global community urgently needs to mobilise and scale available solutions to deliver a decarbonised, sustainable and resilient future.

In response, our network of 75+ Green Building Councils launched the "[Global Policy Principles for a Sustainable Built Environment](#)", ahead of the G7 Ministers' Meeting on Climate, Energy and Environment (15–16 April).

This set of seven principles aims to guide national governments to step up and develop effective policies that prioritise the potential of the built environment to accelerate national and global climate goals.

Our European Regional Network also launched a new report and policy briefing to help accelerate Europe's transformation to a decarbonised built environment: ['Ahead of the Wave'](#) and the [EU policy briefing on Whole Life Carbon](#).

As our network continues to catalyse change on a global scale, our hope for a resilient and sustainable future remains. I look forward to seeing what we will achieve together in the year ahead as our mission continues to grow momentum around the world.


